The Concord Swimming Club was founded in 1968 and presently consists of a large "L-shaped" swimming pool 50' x 120', a wading pool for small children, bathhouse facilities, and grill with adjoining deck.

One-time initiation fee (\$175.00) and annual dues (\$500.00), for a **2012** season total of **\$675.00** (non-refundable). Annual dues and/or special assessments are determined by the Board prior to each season, as is the due date. Members who permit their annual dues to become delinquent shall relinquish their certificates if they do not pay the following year's dues plus all delinquent dues and any special assessments, if they apply, by the due date set by the Board of Directors.

New members are selected by the Board of Directors from the applications on hand and are issued invitations to join, at which time financial obligations to the Club must be met. The Membership Secretary will then issue a Certificate of Membership to the new member. This entitles the member and members of his/her immediate family in the same household to the full use and privileges of the Corporation. "Immediate family", in this connection, shall be deemed to include only, by way of limitation, the spouse and the unmarried children of the member, (provided that "children" as used herein shall include minors living in the household of member who stands in loco parentis to said minor) and shall also include brothers, sisters, and parents of the member or of the member's spouse, who are permanent residents of the member's household.

Prospective members are required to furnish the following information and to list below (on the back of this application if additional space is needed) members of their immediate family, stating relationship of each with birth dates of children, and to have three (3) present members of the Concord Swimming Club sign this application and attach their letters of recommendation.* The three members so acting must be members in good standing.
